Procurement Commission notes that according to Clause 10.4. of Regulation the proposed contract price shall include all taxes, fees and payments, and all costs related to the fulfilment of the obligations specified in the Contract, except VAT. In addition, in footnote under position "Price for investigation point, EUR without VAT"* of the Financial proposal form there is stated that "Financial proposal includes all costs, related to provision of services according to Technical specification (including investigation of potentially

- 1) In order to eliminate any confusion regarding the subject matter of the procurement (military pollution research and remediation), please confirm that the contractor shall ensure the research and remediation of the entire objective area according to the technical specifications and cannot be limited to geotechnical investigation points.
- 2) We also ask you to eliminate the unclarity by giving instructions where and how the tender offer price for military pollution research and remediation must be indicated in the form of the Financial proposal (Annex 1 to the Regulation) (Section 2.1 of the Technical Specifications).

Practically it means that all costs related to potentially investigation of contaminated or contaminated territories with unexploded ordnance, search, identification, collection removal and unexploded ordnance shall be included in position "Price for investigation point, EUR without VAT", booth in part a) (Basic package services according to Technical specification) and part b) (Optional package services according to Technical specification) of the Financial proposal.
