And for which years need to be calculate the average?	Procurement commission indicates, that in accordance with Clause 8.3.1 of Regulations, the Tenderers or all members of the partnership together (if the Tenderer is a partnership and confirms the average financial turnover jointly, average financial turnover within the last 3 (three) financial years 2016, 2017, 2018, is not less than 164 000,00 (one hundred sixty-four thousand euros).			
2.	Annex No 7 "Confirmation of Tenderers financial standing" – liquidity ratio calculates for financial year 2017 or 2018?	Procurement commission indicates, that in accordance with Clause 8.3.2 of Regulation, the liquidity ratio needs to be calculated for the last financial year 2018.			
3.	Should foreign partners from Estonia and Lithuania submit all the documents referred to Clause 8.1 of the Regulation be attached to the submission of the tender documents or will be required on request?	According to the Clause 21.1. of the Regulations, prior to decision making about assigning rights to conclude the Contract, the procurement commission performs a check regarding the existence of grounds for exclusion of tenderers for Tenderers, members of a partnership (if the Tenderer is a partnership), persons on whose capabilities the Tenderer is relying and subcontractors whose share of work is equal to or exceeds 10% of the Contract value.			
		As procurement commission performs a check regarding the existence of grounds for exclusion only prior to making the decision about assigning rights to conclude the Contract, there is no obligation to submit documents about non-exclusion criteria till the proposal submission deadline.			
		However, the Tenderer has rights to submit those documents, as notices and other documents, which are issued by foreign competent institutions, are accepted and recognized by the procurement commission, if they are issued not earlier than 6 (six) month prior to the date of opening of Proposals (Clause 8.1 of the Regulations). For Tenderer, which is registered or residing in Latvia, the
